REGULATION OF THE REGENT OF KUTAI KARTANEGARA NUMBER 3 OF 2024

ON

PROCEDURES FOR ALLOCATION OF REVENUE SHARING OF LOCAL TAXES AND LEVIES FOR VILLAGES FOR 2024 BUDGET YEAR

BY THE BLESSINGS OF ALMIGHTY GOD

REGENT OF KUTAI KARTANEGARA,

Considering

: that in order to implement the provisions of Article 97 section (4) of Government Regulation Number 43 of 2014 on Implementing Regulation of Law Number 6 of 2014 on Villages, it is necessary to issue Regent Regulation on Procedures for Allocation of Revenue Sharing of Local Taxes and Levies for Villages for 2024 Budget Year;

Observing

- : 1. Article 18 section (6) of the 1945 Constitution of the Republic of Indonesia;
 - 2. Law Number 27 of 1959 on Enactment of Emergency Law Number 3 of 1953 on Extension of Establishment of Level II Regions in Kalimantan (State Gazette of 1953 Number 9) as a Law, (State Gazette of 1959 Number 72, Supplement to the State Gazette Number 1820) as amended several times, last by Law Number 8 of 1965 on Establishment of Level II Region of Tanah Laut, Level II Region of Tapin, and Level II Region of Tabalong by Amending Law Number 27 of 1959 on Enactment of Emergency Law Number 3 of 1953 on Establishment of Level II Regions in Kalimantan (State Gazette of the Republic of Indonesia of 1965 Number 51, Supplement to the State Gazette of the Republic of Indonesia Number 2756):
 - 3. Law Number 6 of 2014 on Villages (State Gazette of the Republic of Indonesia of 2014 Number 126, Supplement to the State Gazette of the Republic of Indonesia Number 5495) as amended several times, last by Law Number 6 of 2023 on Enactment of Government Regulation in Lieu of Law Number 2 of 2022 on Job Creation to Become Law (State Gazette of the Republic of Indonesia of 2023 Number 41, Supplement to the State Gazette of the Republic of Indonesia Number 6856);
 - 4. Law Number 23 of 2014 on Local Governments (State Gazette of the Republic of Indonesia of 2014 Number 244,

Supplement to the State Gazette of the Republic of Indonesia Number 5587) as amended several times, last by Law Number 6 of 2023 on Enactment of Government Regulation in Lieu of Law Number 2 of 2022 on Job Creation to Become Law (State Gazette of the Republic of Indonesia of 2023 Number 41, Supplement to the State Gazette of the Republic of Indonesia Number 6856);

5. Government Regulation Number 43 of 2014 on Implementing Regulation of Law Number 6 of 2014 on Villages (State Gazette of the Republic of Indonesia of 2014 Number 123, Supplement to the State Gazette of the Republic of Indonesia Number 5539) as amended several times, last by Government Regulation Number 11 of 2019 on the Second Amendment to Government Regulation Number 43 of 2014 on Implementing Regulation of Law Number 6 of 2014 on Villages (State Gazette of the Republic of Indonesia of 2019 Number 41, Supplement to the State Gazette of the Republic of Indonesia Number 6321);

HAS DECIDED:

To issue

: REGENT REGULATION ON PROCEDURES FOR ALLOCATION OF REVENUE SHARING OF LOCAL TAXES AND LEVIES FOR VILLAGES FOR 2024 BUDGET YEAR.

CHAPTER I GENERAL PROVISIONS

Article 1

In this Regent Regulation:

- 1. Region means the Regency of Kutai Kartanegara.
- 2. Regent means the Regent of Kutai Kartanegara.
- 3. Local Government means the Regent as an element of administration of the Regional government who leads implementation of government affairs which become authority of the Autonomous Region of the Regency of Kutai Kartanegara.
- 4. Sub-district Head means an element of Regional apparatus that assists duties of the Regent in the Sub-district area.
- 5. Village means a legal community unit that has boundaries that are authorized to regulate and manage government affairs, the interests of the local community based on community initiatives, origin rights, and/or traditional rights that are recognized and respected in the government system of the Unitary State of the Republic of Indonesia.
- 6. Village Government means the administration of government affairs and the interests of the local community within the system of government of the Unitary State of the Republic of Indonesia.
- 7. Village Government means the Village Head assisted by the Village Apparatus as an administration element of the Village Government.

- 8. Village Budget (*Anggaran Pendapatan dan Belanja Desa*), hereinafter referred to as APBDesa, means a Village Government annual financial plan.
- 9. Village Cash Account means an account where money of the Village Government that accommodates all Village revenues and used to pay all Village expenditures at a designated Bank.
- 10. Local Tax means a mandatory contribution to the Region owed by individuals or entities that is compelling based on Law, with no direct reward and used for Regional purposes for the greatest prosperity of the public.
- 11. Local Levy means a Regional levy as a payment for certain services or permits specifically provided and/or granted by the Local Government for the benefit of individuals or entities.
- 12. Revenue Sharing of Local Tax and Levy (*Bagi Hasil Pajak Daerah dan Retribusi Daerah*) hereinafter abbreviated as BHPRD means the part of revenue from Local Taxes and Levies which is given to the Village Government.
- 13. Sub-district Head Recommendation means a letter issued by Sub-district Head that states the fulfillment of completeness of requirements in accordance with the provisions.

CHAPTER II ALLOCATION

Article 2

- (1) The Local Government allocates BHPRD to Villages at least 10% (ten percent) of the realization of Local Tax and Local Levy revenues.
- (2) The allocation of BHPRD is a part of the proceeds of Local Taxes and Local Levies received by the Village for 1 year (one) budget.

CHAPTER III CALCULATION OF BHPRD

Article 3

The calculation of BHPRD is carried out based on the following provisions:

- a. 60% (sixty percent) of the BHPRD as a basic allocation and evenly distributed to all Villages based on population classification as follows:
 - 1. for population up to 1,000 (one thousand) people, the evenly distributed allocation is Rp50,000,000 (fifty million rupiah);
 - 2. for population of 1,001 (one thousand and one) to 5,000 (five thousand) people, the evenly distributed allocation is Rp51,773,000 (fifty-one million seven hundred and seventy-three thousand rupiah);
 - 3. for population of 5,001 (five thousand and one) up to 10,000 (ten thousand) people, the evenly distributed allocation is Rp53,000,000 (fifty-three million rupiah); and

- 4. for population more than 10,000 (ten thousand) people, the evenly distributed allocation is Rp61,000,000 (sixty-one million rupiah).
- b. 40% (forty percent) of BHPRD as proportional allocation that is divided proportionally based on the amount of realization of Land and Building Tax revenue for each Village.

Article 4

- (1) The proportional allocation as referred to in Article 3 point b is divided based on the calculation of realization of Land and Building Tax revenue for each Village.
- (2) Calculation of the proportional allocation for each Village as referred to in section (1) is carried out by using the following formula:

AP Desa = (* Z1)* AP Daerah

Notes:

AP Desa = Proportional allocation for each Village

Z1 = ratio of total Land and Building Tax revenue for each Village

AP Daerah = Regional Proportional Allocation.

- (3) Determination of the details of the allocation of BHPRD to each village is listed in the annex as an integral part of this Regent Regulation.
- (4) BHPRD funds received by the Village are included in the APBDesa.

CHAPTER IV PROCEDURE FOR DISTRIBUTION

Article 5

- (1) The distribution of BHPRD is carried out by means of overbooking from the Regional General Treasury Account to the Village Cash Account.
- (2) The distribution of BHPRD funds is carried out simultaneously.
- (3) The distribution of BHPRD is carried out in 1 (one) period.

Article 6

- (1) Requests for BHPRD Distribution are submitted in writing by the Village Head to the Regent Cq. Head of Office of Regional Financial and Asset Management.
- (2) Provisions for the BHPRD Distribution as referred to in in Article 5 section (3) must complete the following requirements:
 - a. requirements for obtaining a Sub-district Recommendation include:
 - 1. statement letter of expenditure responsibility for use of BHPRD;
 - 2. copy of Village regulation on APBDesa;
 - 3. report on the realization of the use of BHPRD of the previous year;
 - 4. photocopy of Village Government cash account;
 - 5. photocopy of the Village Government's taxpayer identification number; and
 - 6. statement of document correctness.

- b. requirement to obtain a letter of introduction from Regional Community and Village Empowerment Office include:
 - 1. statement letter of expenditure responsibility for the use of BHPRD;
 - 2. copy of the Village regulation on APBDesa;
 - 3. report on the realization of the use of BHPRD of the previous year; and
 - 4. recommendation letter from the Sub-district Head regarding the disbursement of BHPRD.
- c. Requirements for distribution to the Office of Regional Financial and Asset Management include:
 - 1. statement letter of expenditure responsibility for the use of BHPRD:
 - 2. recommendation from the Sub-district Head regarding the disbursement of BHPRD; and
 - 3. letter of introduction of the Community and Village Empowerment Office on the disbursement of BHPRD.
- (3) In the event that the disbursement of BHPRD cannot be carried out in the current year which is not caused by negligence of the Village, the disbursement of BHPRD may be implemented in the following year.
- (4) Administration and submission of requirement documents for the distribution of BHPRD as referred to in Article 6 section (2) using application or information technology system in accordance with the needs.
- (5) In the event of submission of requirement documents using the information system as referred to in section (3), it is equipped with a Statement Letter of Document Correctness.

CHAPTER V USE

Article 7

- (1) The BHPRD funds as referred to in Article 4 are prioritized to finance activities in Division of Administration of Government, Community Development and Village Community Empowerment.
- (2) In addition to the use as referred to in section (1), BHPRD funds can be used for activities that directly increase local revenue.
- (3) Activities as referred to in section (1) and section (2) are planned, implemented, and evaluated openly by involving all elements of the village community and discussed in the village development planning meeting (*musyawarah perencanaan pembangunan Desa*, Musrenbangdes) and refers to the RPJMDesa and RKPDes.

CHAPTER VI REPORT

Article 8

(1) The Village Head submits a report on the use of BHPRD funds to the Sub-district Head.

The Sub-district Head submits the report as referred to in section (1) to the Regent through the Community and Village Empowerment Office.

The report as referred to in section (1) is an integrated part of the accountability report for the implementation of the APBDes.

CHAPTER VII CLOSING PROVISION

Article 9

This Regent Regulation comes into force on the date of its promulgation.

In order that every person may know hereof, it is ordered to promulgate this Regent Regulation by its placement in the Regional Bulletin of the Regency of Kutai Kartanegara.
