REGENT OF KUTAI KARTANEGARA.

Considering: a.

- a. that based on the results of the study of Village Institutional Governance from the Regional Research and Innovation Agency, it is necessary to make improvements to the operational implementation of Regulation of the Regent of Kutai Kartanegara Number 6 of 2023 on Village Assistant Task Force "Kukar Idaman";
- b. that based on the considerations as referred to in point a, it is necessary to issue a Regent Regulation on the Second Amendment to Regulation of the Regent of Kutai Kartanegara Number 6 of 2023 on Village Assistant Task Force "Kukar Idaman";

Observing

- 1. Article 18 section (6) of the 1945 Constitution of the Republic of Indonesia;
- 2. Law Number 27 of 1959 on Enactment of Emergency Law Number 3 of 1953 on Extension of Establishment of Level II Regions in Kalimantan (State Gazette of 1953 No. 9) as a Law, (State Gazette of the Republic of Indonesia of 1959 Number 72, Supplement to the State Gazette Number 1820) as amended several times, last by Law Number 8 of 1965 on Establishment of Level II Region of Tanah Laut, Level II Region of Tapin, and Level II Region of Tabalong by Amending Law Number 27 of 1959 on Enactment of Emergency Law Number 3 of 1953 on Extension of Establishment of Level II Regions in Kalimantan (State Gazette of the Republic of Indonesia of 1965 Number 51, Supplement to the State Gazette of the Republic of Indonesia Number 2756);
- 3. Law Number 6 of 2014 on Villages (State Gazette of the Republic of Indonesia of 2014 Number 126, Supplement to the State Gazette of the Republic of Indonesia Number 5495) as amended several times, last by Law Number 6 of 2023 on Amendment to Government Regulation in Lieu of

- Law Number 2 of 2022 on Job Creation into Law (State Gazette of the Republic of Indonesia of 2023 Number 41, Supplement to the State Gazette of the Republic of Indonesia Number 6856);
- 4. Law Number 23 of 2014 on Local Governments (State Gazette of the Republic of Indonesia of 2014 Number 244, Supplement to the State Gazette of the Republic of Indonesia Number 5587) as amended several times, last by Law Number 6 of 2023 on Amendment to Government Regulation in Lieu of Law Number 2 of 2022 on Job Creation into Law (State Gazette of the Republic of Indonesia of 2023 Number 41, Supplement to the State Gazette of the Republic of Indonesia Number 6856);
- 5. Regulation of the Minister of Villages, Development of Disadvantaged Regions and Transmigration Number 18 of 2019 on General Guidelines for Village Community Assistance (State Bulletin of the Republic of Indonesia of 2019 Number 1262) as amended several times, last by Regulation of the Minister of Villages, Development of Disadvantaged Regions, and Transmigration Number 19 of 2020 on Amendment to Regulation of the Minister of Villages, Development of Disadvantaged Regions and Transmigration Number 18 of 2019 on General Guidelines for Village Community Assistance (State Bulletin of the Republic of Indonesia of 2020 Number 1569);
- 6. Regulation of the Regent of Kutai Kartanegara Number 6 of 2023 on Village Assistant Task Force "Kukar Idaman" (Regional Bulletin of the Regency of Kutai Kartanegara of 2023 Number 6) as amended by Regulation of the Regent of Kutai Kartanegara Number 10 of 2023 on Amendment to Regulation of the Regent of Kutai Kartanegara Number 6 of 2023 on Village Assistant Task Force "Kukar Idaman" (Regional Bulletin of the Regency of Kutai Kartanegara of 2023 Number 10).

HAS DECIDED:

To issue

: REGENT REGULATION ON THE SECOND AMENDMENT TO REGULATION OF THE REGENT OF KUTAI KARTANEGARA NUMBER 6 OF 2023 ON VILLAGE ASSISTANT TASK FORCE "KUKAR IDAMAN".

Article I

Several provisions in Regulation of the Regent of Kutai Kartanegara Number 6 of 2023 on Village Assistant Task Force "Kukar Idaman" (Regional Bulletin of the Regency of Kutai Kartanegara of 2023 Number 6) as amended by Regulation of the Regent of Kutai Kartanegara Number 10 of 2023 on Amendment to Regulation of the Regent of Kutai Kartanegara Number 6 of 2023 on Village Assistant Task Force "Kukar Idaman" (Regional Bulletin of the Regency of Kutai Kartanegara of 2023 Number 10) are amended as follows:

1. The provisions of section (2) of Article 2 are amended, so that Article 2 reads as follows:

Article 2

- (1) Under this Regent Regulation, GTPDKI is established.
- (2) The members of GTPDKI as referred to in section (1) are professional personnel who are appointed and determined by a Regent Decision.
- (3) GTPDKI is domiciled in the Region and responsible to the Regent.
- 2. The provisions of Article 3 are amended, so that Article 3 reads as follows:

Article 3

GTPDKI consists of:

- a. Steering Committee: Regent
- b. Person in Charge: Regional Secretary
- c. Chairperson:
- d. Secretary:
- e. Members:
 - Field of Sub-district Function Strengthening, Village Governance, Regulations and Policies related to Rural Village/Urban Village;
 - 2) Field of Rural Village/Urban Village Economy, Rural Village/Urban Village Community Institutions, Village Company or Joint Operation Village Company and Village Cooperation;
 - 3) Field of Community Empowerment, Participatory Development and Rural Village/Urban Village Assistance; and
 - 4) Field of Advocacy, Management Complaints and Problems.
- 3. The provisions of section (3) of Article 6 are amended, so that Article 6 reads as follows:

Article 6

- (1) In carrying out the duties and functions as referred to in Article 4 and Article 5, GTPDKI is assisted by:
 - a. Secretariat; and
 - b. PENDEKAR IDAMAN as technical official.
- (2) The secretariat as referred to in section (1) point a is domiciled in DPMD.
- (3) The Secretariat consists of:
 - a. A Head: an element of the head of the division at DPMD.
 - b. Members: elements of civil servants, non-civil servants in DPMD, and administrative personnel professionals who are given honorarium in accordance with applicable provisions.
- (4) The Members of Secretariat as referred to in section (3) point b are appointed and dismissed by the Head of DPMD.
- (5) The members of Secretariat as referred to in section (4) are not members of the GTPDKI.

4. The provisions of Article 11 are amended, so that Article 11 reads as follows:

Article 11

- (1) In carrying out its duties, GTPDKI is given honorarium, operational costs and insurance every month.
- (2) GTPDKI under contract with other Institutions/Agencies that receive honorarium from the State Budget/Local Budget, will not receive honorarium as GTPDKI, only get operational costs and insurance every month.
- (3) In addition to the honorarium, operational costs and insurance as referred to in section (1), GTPDKI is entitled to receive honorarium for public speaker for seminar/dissemination/symposium/workshop/focu s group discussion in accordance with the regional unit price standard.
- (4) In carrying out its duties, the GTPDKI may be provided with work support means, infrastructure and operational vehicles which implementation is in accordance with legislation.
- (5) The implementation as referred to in section (1) and section (3) is guided by provisions regarding the Regional Unit Price Standard.

Article II

This Regent Regulation comes into force on the date of its promulgation.

That every person may know hereof, it is ordered to promulgate this Regent Regulation by its placement in the Regional Bulletin of the Regency of Kutai Kartanegara.
