

REGULATION OF THE REGENT OF KUTAI KARTANEGARA  
NUMBER 8 OF 2024  
ON  
ESTABLISHMENT OF KEMBANG JANGGUT ULU PREPARED VILLAGE  
IN KEMBANG JANGGUT SUB-DISTRICT

BY THE BLESSINGS OF ALMIGHTY GOD

REGENT OF KUTAI KARTANEGARA,

- Considering : a. that in order to realize an effective Village governance, accelerate the improvement of Community welfare and the quality of public services as well as improve the quality of Village governance and Village competitiveness, it is necessary to arrange Villages;
- b. that there are aspirations of the people of Kembang Janggut Village who want a village arrangement in the form of village expansion;
- c. that the village expansion initiative as referred to in point b has fulfilled the requirements in accordance with the legislation;
- d. that the provisions of Article 22 section (3) of Regulation of the Minister of Home Affairs Number 1 of 2017 on Village Arrangement, in the event that the Regent approves village expansion, the Regent stipulates a Regent Regulation on Establishment of Prepared Village;
- e. that based on the considerations as referred to in point a, point b, point c and point d, it is necessary to stipulate a Regent Regulation on Establishment of Kembang Janggut Ulu Prepared Village in Kembang Janggut Sub-district.
- Observing : 1. Article 18 section (6) of the 1945 Constitution of the Republic of Indonesia;
2. Law Number 27 of 1959 on Stipulation of Emergency Law Number 3 of 1953 on Extension of the Establishment of Level II Regions in Kalimantan (State Gazette of 1953 No. 9) as a Law, (State Gazette of the Republic of Indonesia of 1959 Number 72, Supplement to the State Gazette Number 1820) as amended several times, last by Law Number 8 of 1965 on Establishment of Level II Region of Tanah Laut, Level II Region of Tapin, and Level II Region of Tabalong by Amending Law Number 27 of 1959 on Enactment of Emergency Law Number 3 of 1953 on Extension of Establishment of Level II Regions in

Kalimantan (State Gazette of the Republic of Indonesia of 1965 Number 51, Supplement to the State Gazette of the Republic of Indonesia Number 2756);

3. Law Number 6 of 2014 on Villages (State Gazette of the Republic of Indonesia of 2014 Number 126, Supplement to the State Gazette of the Republic of Indonesia Number 5495) as amended several times, last by Law Number 6 of 2023 on Amendment to Government Regulation in Lieu of Law Number 2 of 2022 on Job Creation into Law (State Gazette of the Republic of Indonesia of 2023 Number 41, Supplement to the State Gazette of the Republic of Indonesia Number 6856);
4. Law Number 23 of 2014 on Local Governments (State Gazette of the Republic of Indonesia of 2014 Number 244, Supplement to the State Gazette of the Republic of Indonesia Number 5587) as amended several times, last by Law Number 6 of 2023 on Amendment to Government Regulation in Lieu of Law Number 2 of 2022 on Job Creation into Law (State Gazette of the Republic of Indonesia of 2023 Number 41, Supplement to the State Gazette of the Republic of Indonesia Number 6856);
5. Regulation of the Minister of Home Affairs Number 1 of 2017 on Village Arrangement (State Bulletin of the Republic of Indonesia of 2017 Number 155).

HAS DECIDED:

To issue : REGENT REGULATION ON ESTABLISHMENT OF KEMBANG JANGGUT ULU PREPARED VILLAGE IN KEMBANG JANGGUT SUB-DISTRICT.

## CHAPTER I GENERAL PROVISIONS

### Article 1

In this Regent Regulation:

1. Region means the Regency of Kutai Kartanegara.
2. Regent means the Regent of Kutai Kartanegara.
3. Sub-district means the working area of the Sub-district Head as the Regency Regional Apparatus.
4. Sub-district Head means the Head of Sub-district who is under and responsible to the Regent.
5. Village means a legal community unit that has boundaries that are authorized to regulate and manage government affairs, the interests of the local community based on community initiatives, origin rights, and/or traditional rights that are recognized and respected in the government system of the Unitary State of the Republic of Indonesia.
6. Village Government means the administration of government affairs and the interests of the local community within the system of government of the Unitary State of the Republic of Indonesia.
7. Acting Village Head means a Civil Servant as a temporary official appointed by the Regent to exercise the duties, authority, obligations and rights of the village head for a certain period of time.

8. Village Apparatus means a staff element that assists the Village Head in policy formulation and coordination, which is contained in the Village Secretariat, and supporting elements of the Village Head's duties in implementing policies in the form of technical implementers and territorial element.
9. Neighborhood (*Rukun Tetangga*), hereinafter abbreviated as RT, means a community institution formed by the Village Government as a part of the village administrative area to maintain and preserve the values of life based on cooperation, help improve the smooth running of government, development and the community tasks in the village as well as increasing community participation in Development.
10. Village Council means an institution carrying out government functions whose members are representatives of the village population based on regional representation and democratically determined.
11. Local Budget (*Anggaran Pendapatan dan Belanja Daerah*), hereinafter abbreviated as APBD means an annual regional financial plan which is stipulated by a regional regulation.
12. Village Budget (*Anggaran Pendapatan dan Belanja Desa*), hereinafter referred to as APBDesa, means a Village Government annual financial plan.
13. Prepared Village means a part of one or more neighboring Villages which is prepared to be formed into a new Village.
14. Main Village means the original Village that was expanded from the Prepared Village that was formed.

## CHAPTER II ESTABLISHMENT, AREA, BOUNDARIES, AND SCOPE

### Article 2

Under this Regent Regulation, Kembang Janggut Ulu Prepared Village is established, which is an expansion of Kembang Janggut Village in Kembang Janggut Sub-district and has a Register Code of 02.10.04.06 with an area of 11,155.83 Ha.

### Article 3

- (1) Kembang Janggut Ulu Prepared Village consists of the following areas which includes RT.8, RT. 9, RT. 10, RT. 11, RT. 12, RT. 13, RT. 14, and RT. 15 with the following boundaries:
  - a. North bordering with Kelekat Village;
  - b. South is bordered by Kembang Janggut Village;
  - c. East is bordered by Kembang Janggut Village; and
  - d. West bordered by Kelekat Village.
- (2) The boundaries of Kembang Janggut Ulu Prepared Village area as referred to in section (1) is stated in the provisional area map as listed in Annex as an integral part of this Regent Regulation.
- (3) Stipulation, confirmation and ratification of territorial boundaries as referred to in section (1) are carried out after established as a definitive Village in accordance with the provisions of legislation.

Article 4

With the establishment of Kembang Janggut Ulu Prepared Village as referred to in Article 2, the area of Kembang Janggut Village is reduced by the area of Kembang Janggut Prepared Village as referred to in Article 3.

CHAPTER III  
VILLAGE GOVERNMENT

Part One

Acting Village Head and Village Apparatus

Article 5

Government of Kembang Janggut Ulu Prepared Village is carried out by the Acting Village Head who is assisted by Village Apparatus.

Article 6

- (1) The Acting Village Head as referred to in Article 5 comes from Local Government Civil Servant with the following requirements:
  - a. understands the field of leadership and technical government;
  - b. is experienced in the field of government which is proven by work history; and
  - c. has an employee performance appraisal for 5 (five) years at least well.
- (2) The Acting Village Head as referred to in section (1) is appointed by the Regent after receiving the Governor's letter containing the registration code of Kembang Janggut Ulu Prepared Village of Kembang Janggut Sub-district.
- (3) The appointment of Acting Village Head as referred to in section (2) is stipulated by a Regent Decision.
- (4) The term of office of the Acting Village Head as referred to in in section (3) ends after the formation of the definitive Village.

Article 7

- (1) The Village Apparatus as referred to in Article 5 is a Village Apparatus from Kembang Janggut who domiciled in the area of Kembang Janggut Ulu Prepared Village.
- (2) In the event that the Village Apparatus as referred to in section (1) does not exist or the number is not compatible with the needs, the Acting Village Head may appoint Village Apparatus who domiciled outside Kembang Janggut Ulu Prepared Village area.
- (3) The appointment of Village Apparatus as referred to in section (2) is carried out after coordinating with the Village Head of Kembang Janggut.

Article 8

- (1) The Acting Village Head as referred to in Article 5 has the authority to carry out preparations for the formation of definitive Village with the following duties:

- a. determine the boundaries of the Village area in accordance with the cartographic principle;
  - b. carry out the management of the Village operational budget that is sourced from the main Village Budget;
  - c. establish an organizational structure;
  - d. appoint the Village Apparatus;
  - e. preparation of basic facilities for Village residents;
  - f. development of Village Government means and infrastructure;
  - g. data collection in the field of population, economic potential, land inventory and development of economic, educational and health facilities; and
  - h. creating of inter-village transport access.
- (2) In performing the duties as referred to in section (1), the Acting Village Head performs the following activities:
- a. prepare a Village development work plan by including the participation of the prepared Village community to be submitted to the main Village Head; and
  - b. participate in the discussion of the main Village budget.
- (3) In carrying out the activities as referred to in section (2), the Acting Village Head is responsible to the Regent through the Main Village Head.

## Part Two Village Council

### Article 9

- (1) Implementation of Village Government functions in Kembang Janggut Ulu Prepared Village is the authority of the Village Council.
- (2) The authority of the Village Council as referred to in section (1) is exercised by members of the Village Council of Kembang Janggut until the formation of the Village Council after Kembang Janggut Ulu Prepared Village is established as a definitive Village.
- (3) Formation of the Village Council as referred to in section (2) is implemented democratically in accordance with the provisions of legislation.

## PART IV GUIDANCE AND SUPERVISION

### Article 10

- (1) The Regent through the Regional Apparatus in charge of government affairs in the field of Village Government and/or the Sub-district Head conducting guidance and supervision of implementation of Kembang Janggut Ulu Prepared Village Government.
- (2) Guidance and supervision as referred to in section (1) are carried out in accordance with the provisions of legislation.

## CHAPTER V REPORTING AND EVALUATION

### Article 11

- (1) The Acting Village Head as referred to in Article 5 reports on the progress of the implementation of the Kembang Janggut Ulu Prepared Village on a regular once every (six) months to:
  - a. the Regent through the Sub-District Head; and
  - b. the Kembang Janggut Village Head.
- (2) Progress report on the implementation of the Kembang Janggut Ulu Prepared Village as referred to in section (1) contains the results of the implementation of the duties of the Acting Village Head in preparation for the formation of the definitive Village as referred to in Article 8 section (1).
- (3) Report on the results of the implementation of the duties of the Acting Village Head as referred to in section (2) becomes material for reviewed and verified by the Village Formation Team on the feasibility of Kembang Janggut Ulu Prepared Village to become a definitive village.

## CHAPTER VI FINANCING

### Article 12

- (1) Means and infrastructures development budget and allocation of operational costs of Kembang Janggut Ulu Prepared Village is sourced from the Kembang Janggut Village Budget.
- (2) The allocation of operational costs as referred to in section (1) at a maximum of 30% (thirty percent) of Kembang Janggut Village Budget.
- (3) In the event that the budget for the development of means and infrastructures of Kembang Janggut Ulu Prepared Village as referred to in section (1) is unable to be financed from Kembang Janggut village budget, the financing is borne by the local budget.
- (4) The budget for the development of means and infrastructures of Kembang Janggut Ulu Prepared Village of which financing is borne by the local budget as referred to in section (3) may be allocated through financial assistance from the Kembang Janggut Village budget.

## CHAPTER VII CLOSING PROVISION

### Article 13

This Regent Regulation comes into force on the date of its promulgation.

That every person may know hereof, it is ordered to promulgate this Regent Regulation by its placement in the Regional Bulletin of the Regency of Kutai Kartanegara.
